



GOLF CART AGREEMENT AND REGISTRATION FORM

1. The golf cart owner must sign a copy of the Golf Cart Agreement and Registration Form each year they bring in and operate a golf cart at any one of the iCampIndiana campgrounds including Blue Lake Campground, Indian Springs Campground, Gordons Campground, Atwood Lake Campground, Camp Sack-In, Sport Lake Campground, and Forest Ridge Campground, herein referred to as Campground. The fee is \$25 per golf cart for the 2025 registration. The registration expires at the end of the camping season.
2. Registration Requirements
 - a. The owner of the golf cart must maintain Personal Injury and Property Damage Liability Insurance on golf carts and verify that their insurance covers all authorized drivers (family, friends, etc.). Proof of insurance is required and must show coverage of \$100,000 to \$300,000 liability on the policy.
 - b. The owner must agree to follow the rules included in this agreement, and those posted in the campground and must display the registration sticker of the current season on the front driver side of the golf cart.
 - c. "2-cycle" engine golf carts are NOT allowed in the campground.
3. Operator(s) of golf carts must be at least 16 years of age with a valid driver's license and covered under the golf cart owner's insurance.
4. Golf carts driven after sunset must have working headlights and at a minimum, rear reflectors.
5. **No golf carts are to be driven between the hours of 11 pm to 8 am (Quiet Hours), Fridays & Saturdays 12 am to 8 am (Quiet Hours).**
6. Golf carts are only allowed on designated roadways and are NOT to be driven through campsites, on sidewalks, or on the beach or grassy areas. All passengers must be safely seated on the golf cart, children may not sit on the driver's lap. A golf cart is limited to as many passengers as there are seats.
7. The golf cart owner is responsible for the operation of the cart. The owner, operator, and all passengers shall indemnify and hold the Campground harmless from and against any liability, including bodily injury and property damage arising out of the use/operation of the equipment by the golf cart owner and anyone using/operating the cart.
8. Do not drive through the entrance or exit gate. Any injury, damage, or charges will be the responsibility of the driver.
9. The speed limit is 5 miles per hour. Reckless driving and/or excessive speed will result in immediate forfeiture.
10. **Golf Cart Violations result in the following actions: (ZERO TOLERANCE) – All fines must be paid before privileges are reinstated.**
 - 1st Offense: \$25 fine levied against the registered owner and suspension for two (2) weeks.
 - 2nd Offense: \$50 fine levied against the registered owner and suspension of golf cart privileges for four (4) weeks.
 - 3rd Offense: \$100 fine levied against the registered owner and suspension of golf cart privileges for the season.

****During the suspension time, the golf cart is not to be driven by anyone and the owner/driver of the golf cart, who violated the rules, will not be able to drive any golf cart or ride on any golf cart with another person. Violation of suspension will result in immediate suspension of golf cart privileges for the remainder of the season and your site rental privileges may be revoked with no refund.****

I agree to follow and enforce these rules and requirements upon anyone that may operate my cart, including myself, and I assume full responsibility. By signing below, I am stating that I have fully read, understand, and agree to the term and conditions set out in this agreement. Anyone found abusing the rules and regulations of the Golf Cart Agreement and Registration will forfeit all golf cart operation privileges.
